

2017 Fall Camping at Tannehill

The following procedures for camping will be enforced during September and October 2017.

Please note that all campground rules still apply

1. All decorations (including hay bales) must be removed upon departure from the camping area. Please note: as a fire precaution all hay used for decoration must remain baled; it is not permissible to spread hay on the ground of any campsite. To accommodate emergency vehicle traffic, all decorations, easy ups, furniture, satellite dishes and vehicles, etc., must be completely on the campsite and well clear of all roadways.
2. Camper registration is 7:00am until 10:00pm. All campers **must register before** proceeding to a camp site.
3. Holding or saving empty sites is **NOT ALLOWED**. Any tent used to secure a site must be factory manufactured with the site registered and official camping card attached to it. The tent must be located in or near the middle of the site where it can be clearly determined what site the tent is located on. Any tent without a registration card will be removed by Tannehill State Park Staff. **Once an RV is placed on the site the tent must be taken down.**
4. Due to abuse, extra tents are **NOT ALLOWED** on sites; even for small children. **Each campsite may have only one camping unit per site and only one screened room for dining purposes.**
5. **No more than 2 vehicles are allowed at a campsite.** This will be strictly enforced. Campers who will be staying with us through Halloween will be issued **2** Halloween parking passes.
6. Due to vandalism, certain areas of the park will be closed at dusk. These areas include the Furnace, Church, School House, Fowler House, and Grist Mill. Anyone in those areas after dark will be asked to return to their campsite. If the trespassing continues you may be asked to vacate your campsite. Refunds will not be issued.
7. Those campers wishing to go to Farley Field the Tuesday after Trade Day will be given a numbered card on October 7th, 2017. You must have a paid camper/tent in primitive area in order to receive a number. At noon, Tuesday Oct 24th, 2017 the Tannehill Campground Staff will begin taking campers to Farley Field. **If you are not at your camper when your number is called, you will be passed over, and the next numbered person will be taken to Farley Field.**
8. On Saturday October 28th at 11:00am – 9:00pm, the **camping area will be closed to vehicular traffic of any kind.** Streets within the campground will be closed to bikes, scooters, skate boards, and roller blades at 11:00am. If you need to exit the camping area during those times it is recommended that you park your car in Farley Field. If you leave the park on Saturday, it is recommended that you return before 11:00am or expect to wait in line to reenter the park and park your car in Farley Field. Please remember that on October 28, 2017 Special Event gate admission will be charged per trip through gate.

The main park gate will remain open and manned.

9. No camping passes will be handed out at the gate.
