

2017 TANNEHILL TRADE DAY RULES AND INFORMATION

Any reserved spaces that are not paid by the designated deadline will be considered open and available to rent on a first come first served basis. TRADE DAYS weekend a park employee will be available on Friday in the Edward's House at 8:30 a.m. and on Saturday in Farley Field at 8:00 a.m. to rent any open spaces. There are NO REFUNDS OR ROLLOVERS on paid spaces.

HOURS: 8:00 a.m. – 4:00 p.m. Saturday & Sunday. Dealers should keep booths open during these hours.

SETUP TIME: Starts at 7:00 a.m. Friday and Saturday. Dealers who setup in the wrong space will be required to move. **Dealers must be setup by 8:00 a.m. on Saturday or their space may be forfeited for the weekend. No vehicular traffic in Trade Day area after 8:00 a.m.. Late arrivals must park in parking lot.** Dealers not setup or on site by 8:00 a.m. on Sunday may forfeit their space for that day. Dealers with a shed space must move their vehicles to a parking lot. Farley Field will be closed from 7:30 a.m. on Thursday until 6:30 a.m. on Friday except to park employees. There will be no early TRADE DAY dealer arrivals at Farley Field on Thursday. Dealers must not camp in the TRADE DAYS area unless they are in their paid space.

SPACE: approximately 15 feet wide and 20 feet deep. Displays, tables and all merchandise **must be two (2) feet back from the edge of the road or walk to allow room for emergency vehicles.**

ELECTRICITY: Due to the potential of overloading the electric system and creating safety problems with extension cords, **ONLY** the vendor with a paid electric space is allowed to plug in at that site.

RENEWAL OF REGULAR AND OVERFLOW SPACE: TRADE DAY dealers have the option to renew the space they have (1) monthly, (2) for several months in a row or (3) for the entire year. A park employee will be at the Hoot 'N Holler on Saturday from 8 - 11 a.m. and on Sunday from 8 - 11 a.m. for dealers to renew their space. Any space not renewed by 11 AM on Sunday will be available to rent for the next month. We will create a "Place in Line List" for renting available spaces. We will call you on Monday with the available spaces for the following month. You will have priority on the open spaces. Beginning Tuesday after TRADE DAYS, any open spaces may be rented for the next month's TRADE DAYS by calling or coming to the park office. The park phone number is 205-477-5711. Phone reservations taken the week of TRADE DAYS must be paid by credit card.

SALE OF THE FOLLOWING IS PROHIBITED: The park's contract for food/drink concessions prohibits anyone other than the person who has the contract or one of his appointed agents to sell drinks or prepared foods such as cookies, candies, sandwiches, cakes, canned soda or bottled water. Real or toy guns of any type, ammunition, unlicensed or counterfeit copyright merchandise, animals, snap-pops, fireworks, explosive devices, tasers, stun-gun, brass knuckles, chemical self-defense spray, profane or pornographic material, games of chance or any other item(s) so deemed by the Park Ranger, Alabama Historic Ironworks Commission or the Parks Administrator are strictly prohibited.

CLEAN UP: TRADE DAY dealers must clean up their space. **Bag all garbage and carry it and any other trash and boxes to the dumpster or set it at the edge of the road to be picked up.**

GENERAL RULES:

- 1. No pets are allowed anywhere in the TRADE DAYS area including being "hidden away" in a motor home or other vehicle. This applies to dealers and park visitors and will be enforced.**
No skates, roller blades, skateboards, recreational scooters, bicycles or vehicles are allowed in the TRADE DAYS area during market hours. Customers picking up merchandise in vehicles should contact employee at bridge and arrange pick-up.
- 3. No alcoholic beverages are allowed in the park.**
- 4. All park camping regulations will be enforced where applicable in the TRADE DAY area.** Quiet hours are 10 p.m. until 6 a.m. Only well maintained muffled generators may be used and they must be turned off during quiet hours. Smoky or noisy generators are prohibited. In the event of a generator noise or smoke problem, the judgment of the park supervisor or security person is final.
- 5. Tannehill Ironworks Historical State Park is not responsible for dealer merchandise or personal property.**
- 6. Dealers are responsible for collecting and paying all applicable sales tax. Alabama tax is 4% and Jefferson County tax is 2%. Please contact the Alabama Department of Revenue or the Jefferson County Department of Revenue if you have tax questions.**
- 7. Everyone coming in the park between 8:00 a.m. and 4:00 p.m. on Saturday and Sunday of Trade Days weekend must pay park admission. Dealers and their helpers who go in and out during these hours must show their CURRENT TRADE DAY receipt at the gate or they will be charged gate admission.**

PLEASE BE AWARE THAT VIOLATION OF TRADE DAYS OR PARK RULES COULD RESULT IN BEING ASKED TO LEAVE THE PARK.
